

**MUSIC CLUB OF HOLLYWOOD FLORIDA  
GENERAL INFORMATION FOR 2020 MOLLY GARRETT  
AND JUNE FOOSHEE COLLEGIATE GRANTS**

**ELIGIBILITY:**

1. The student must be a high school graduate prior to or during June of the year of application. A statement from the high school authority identifying the student as a member of that year's graduating class and stating that the applicant is graduating may be required. If the applicant has received a high school diploma or equivalent prior to the year of application, the applicant must furnish the copy or original of such and it must be verifiable by the appropriate school authority.
2. A document from the music school the student plans to attend stating that the student has been accepted or is already enrolled in their music school is required with the application.
3. A written recommendation from the applicant's music teacher or director prior to entering college or, if already attending college, a letter from his music teacher or director must accompany the application.
4. The student must be planning or enrolled as a major in music at an accredited music school. College students who receive grants from the Music Club of Hollywood Florida must be enrolled as a music major in a full-time program at an accredited college or university.
5. Missing or incomplete applications may be disqualified and/or ineligible for an audition.

**GENERAL INFORMATION AND INSTRUCTIONS:**

1. The grant recipient shall be chosen on the basis of merit, musical ability, character and need following an audition before the scholarship committee.
2. The college must be accredited but is of the student's choosing. It is not a requirement that the student attends a Florida school.
3. The payment of the grant shall be to the student upon receipt of proof of college enrollment
4. The Scholarship Committee's decision, based on the judges' input will be final.
5. The awards are funded annually by the Music Club of Hollywood Florida. The number and dollar value of the awards may vary from year to year.
6. Grant Applicant must be an American citizen.
7. Applicants must be a current resident of Broward or Dade County, Florida.
8. Late or incomplete applications are grounds for disqualification.
9. Upon receipt of the scholarship award from the Music Club of Hollywood Florida, the student will receive a one-year free membership in the club. In subsequent years, recipient students are encouraged to maintain their membership and will be responsible for annual dues of \$45.
10. The awards will be by check when the awardee has submitted a copy of acceptance from a college or proof of courses to be taken for the semester. In this instance, the student assumes responsibility for any tax issues that may arise or the Spring term.
11. Checks cannot be issued to the student until evidence of college acceptance is furnished (for rising Freshmen or transfer students).
12. The Music Club of Hollywood Florida reserves the right to use audio and video recordings of performances under our sponsorship for promotional purposes on our website and other media. We will ask the student permission for use of media that is made public on Youtube.com and other video sharing sites that are searchable on the internet.
13. Failure to comply with any of the eligibility or application requirements may be cause for disqualification.
14. The 2019 grant will be a one-time award. The student must audition in subsequent years to compete for another award.

### **AUDITION REQUIREMENTS:**

1. A Grant Application must be completed in full and postmarked by **February 24, 2020**.
2. The applicant should prepare a program of no less than ten minutes. Longer programs are allowed but the Scholarship Chairman reserves the option of terminating the audition program after 10 minutes. All selections should preferably be performed from memory.
3. Works should be carefully chosen to display the student's best abilities and the highest standards of performance. The number of selections chosen will be determined by the time allowed for each student.
4. The Music Club of Hollywood Florida will provide a piano accompanist at no charge. Piano music must be received for the accompanist (by the Scholarship Chairman) by **March 10, 2020**. Students may also choose their own accompanist if they so desire. If the applicant opts to use our accompanist he/she must arrive early to rehearse. The Scholarship Chairman will provide details prior to the audition. Rehearsals with our accompanist will begin at 8:00 A.M. in order of arrival.
5. All applicants should arrive thirty minutes before the audition starts. Late arrival is grounds for potential disqualification. Applicants are expected to stay for all performances. If not using or do not need our accompanist he/she must submit only their title to us by **March 24, 2020**.
6. One published copy and two photocopies of each selection to be performed by the applicant are to be presented to the Scholarship Chairman at the audition. Please mark your music with your name and address. The music will be used by the judges and returned to the applicant after the audition.

### **AUDIO OR VIDEO SUBMISSION REQUIRED:**

**The applicant is required to submit an audio or video sample of their work of about 10 minutes duration. It can be a CD, DVD, MP3, or VIDEO FILE. Please include it with the application. Files may also be also posted on a download site and, if so, please provide the link to [MCOHscholarship2@gmail.com](mailto:MCOHscholarship2@gmail.com).**
